

**RESOLUTION 21-04
OF THE BOARD OF DIRECTORS OF HELIX WATER DISTRICT
DECLARING CONSTRUCTION COMPLETE AND
AUTHORIZE FILING A NOTICE OF COMPLETION FOR
BELLA TERRAZZA-MAIN RANCH WATER MAIN EXTENSION PROJECT RMB18035**

WHEREAS, Helix Water District has heretofore entered into a contract with **CWC El Cajon 139 LLC** of Carlsbad, California for the Bella Terrazza-Main Ranch water main extension project RMB18035. The private development project consisted of the installation of 3,530 feet of 8-inch PVC pipe, 820 feet of 12-inch PVC pipe, 12 fire hydrants, two 4-inch blow-offs and 141 1-inch water services. **RMB18035** is within the boundaries of the district, in the city of El Cajon, state of California; and

WHEREAS, such work for the project has been completed successfully by the contractor (C.E. Wilson Corporation) and it is in the interest of the district to accept such work and to file a notice of completion.

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the Helix Water District Board of Directors as follows:

1. That said work be hereby accepted by the district, provided that such acceptance not be construed as constituting any waiver of any rights of the district, and provided further that such acceptance shall not in any way affect the warranties and guaranties given by the contractor and/or owners of the property as to the quality of the work performed and as to the proper functioning of said facilities.

2. That the president and secretary be and they hereby are authorized and directed to execute a notice of completion in the office of the county recorder of the county of San Diego.

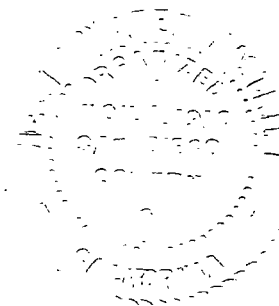


3. The property on which said work of improvement was completed is in Helix Water District in the county of San Diego, state of California, and is described as follows:


4. The name of the original contractor, if any, for said work of improvement as a whole was **C.E. Wilson Corporation**.
